The Dream Team Women's Network was established in September 2010. The success of our network relies entirely on the active participation of its members. Effective networking demands dedication. As a team, we are accountable for adhering to the organization's policies and procedures outlined in the Dream Team Women's Network Policies and Procedures.

Mission

To be THE center of professional influence in the Greater Dallas Business Community, for women.

Vision

To be the Center of Influence in Dallas by attracting successful and well-regarded female business and community leaders by leveraging their professional networks for the benefits of the greater community. Our group's goal is to build relationships among women from various industries to expand our networks and serve as a resource for our clients in corporate and business services. A distinctive feature of Dream Team is our annual selection of a non-profit agency to support with our time and talent. We provide a unique culture of support, integrity, and professional development to our expanding membership.

Policies and Procedures:

Only female professionals are eligible to be members of the Dream Team Women's Network.

Member participation is the greatest single factor in the success of this group. All members are expected to schedule 1 on 1's with other members monthly in addition to attending the monthly lunch meeting. Members participate by bringing referrals to other members and invite guests who *cannot be a conflict with any currently filled Dream Team Member seat*. If there is a question if someone is a conflict, the Dream Team Members can reach out to the VP of Membership or President prior to the monthly meetings.

Dues:

The annual membership dues and lunch are \$600.00 per calendar year. All members' renewal dues will be payable by the first Tuesday of March.

Upon joining the Group, membership dues and lunch costs will be prorated for the first year and are due upon acceptance into the group.

Attendance:

If a current Dream Team Member has to miss a monthly meeting, they are highly encouraged to find a substitute to attend in their place. The substitute *cannot be a conflict with any currently filled Dream Team Member seat*. If there is a question if someone is a conflict, the Dream Team Members can reach out to the VP of Membership or President prior to inviting a substitute to a meeting.

A current Dream Team Member may miss up to two (2) meetings within the calendar year without sending a substitute. If there are extenuating circumstances to the absences, including medical/maternity leave, the Dream Team Member should reach out to the President to discuss. Upon missing two (2) meetings with no substitute, the Board President will reach out to the Dream Team Member with a reminder of the policy. If a current Dream Team Member misses three (3) meetings with no extenuating circumstances, discussion or substitute, their membership will be reviewed by the Board. The Board President will reach out to the member with the Board's decision.

Philanthropy:

A unique aspect of Dream Team Women's Network is the annual selection and support of a charity. Each member is expected to participate in the selection process by voting and then supporting the selected charity by participating in activities through the year, by volunteering for the chosen entity, and by supporting the chosen recipient financially. Specifically, each member is expected to participate in our annual fundraiser by purchasing a ticket for the event and donating a raffle item with a value of \$100 or more or making a cash donation of \$100 or more. Members are also encouraged to invite guests.

Membership Process:

Only one woman from each professional specialty that represents their primary occupation (not a part-time business) is accepted to join the Dream Team. Prior to extending an offer of membership to any prospective member, the following must occur:

1. The prospect shall attend a Dream Team lunch meeting to meet the group; and not more than two (2) meetings without submitting an application for membership.
2. The prospect shall submit an application to the membership committee. The membership committee shall review the member's application and ensure her professional specialty does not conflict with any current members.
3. The prospect will subsequently meet with the majority of the Board within 60 days, who will vote on the prospective new member at the next board meeting after the prospect has met the above qualifications for membership.
4. The VP of Membership or a Membership committee member will notify the prospective member of the board decision.

Dream Team Women's Network Board and Committees

The Board meets monthly to act as a steering committee for the organization, review prospective new members and discuss upcoming plans and events. The Board Leadership will be reviewed every year. Members who wish to may apply to the President for consideration. In the event a member of the Board can no longer serve, the President will appoint a replacement for the remainder of her term.

The Board's Executive Officers consist of the President, President-Elect, Historian, VP of Programs, VP of Membership, VP of Philanthropy, Treasurer and Communications Director. The Past President is also a part of and a voting member of the Board for the year following her Presidency. Additionally, there are committees which have committee chairs and members.

These committees include:

- **Membership**, who helps greet guests at meetings and gather needed information from new members
- **Programs/Social**, who help plan out and run the year's programs during the monthly lunches and plans 1 – 2 social events for the membership, and also is part of the auction event committee
- **Philanthropy**, who plan and execute the annual auction event and any other events that occur on behalf of the selected charity
- **Treasury**, who helps with check in, membership dues and follow up to members.
